Democrat Arizona House Representative Ruben Gallego refused to answer The Gateway Pundit's questions on Wednesday about his questionable win against Kari Lake in the US Senate election on November 5.

Not only does Richer detest Kari Lake, but he's also neighbors and seemingly friends with Lake's 2024 Senate opponent. Likewise, Ruben Gallego "f*cking hates" Kari Lake and "wants her to die," according to a former Democratic Senate aide.

<u>Soros-backed</u> and <u>cartel-tied</u> Ruben Gallego supposedly beat Kari Lake by <u>over 80,000</u> <u>votes</u> in the Senate race. Meanwhile, President Trump won the state of Arizona by nearly 190,000 against Kamala Harris.

When questioned about his friendship with Maricopa County Recorder Stephen Richer, his family ties to the cartel, and whether or not his election was run fairly, Gallego had no answers.
